HIGHLIGHTS OF OUR WORK

- ▶ Represented StateHouse Holdings Inc. (formerly Harborside Inc.; CSE: STHZ; OTCQX: STHZF), a vertically integrated cannabis enterprise, in its \$43.8 million acquisition of 100% of the issued and outstanding equity of Sublimation Inc., a cannabis manufacturing company located in Oakland, California.
- ▶ Represented Devine Holdings in its settlement of the dispute and membership purchase agreement of three medical cannabis licenses in Arizona with Harvest Health & Recreation Inc. (CSE: HARV; OTCQX: HRVSF), a vertically integrated cannabis company and multistate operator in the U.S.
- ▶ Represented iAnthus Capital Holdings, Inc. as U.S. counsel in connection with its all-stock merger with MPX Biocetical Corp., and offering equity consideration to MPX shareholders valued at \$1.6 billion, representing the first “public to public” merger in U.S. cannabis history.

- ▶ Cannabis regulatory counsel for a private credit asset management firm in connection with a \$50 million secured financing to a premier producer of packaging and other ancillary products and services to the cannabis and hemp industries.
- ▶ Represented A.G.P./Alliance Global Partners Inc. in a \$36 million “registered direct” public offering of common stock and warrants for cannabis company Kush Bottles Inc. The transaction is believed to be the first investment-bank-led public offering for a U.S. cannabis company.

This is a case of first impression, as no court has addressed whether the marketing of cannabis-related products can result in infringement of a federally registered trademark.
- ▶ Conducted a 12-state analysis of federal and state regulatory framework pertaining to the distributing, marketing and selling of hemp and hemp-derived cannabidiol (CBD), including in California, Virginia, Maryland, North Carolina, Pennsylvania, Ohio, Kentucky, Indiana, West Virginia, Oregon, Washington and New York.
- ▶ Represented Cannex Capital Holdings, Inc., a large-scale cannabis cultivator and manufacturer, as U.S. counsel in connection with its merger with cannabis company 4Front Holdings LLC to form 4Front Ventures Corp. (CSE: FFNT).
- ▶ Cannabis regulatory counsel for one of the world’s largest Canadian cannabis companies with its expansion into the U.S. market through a \$300 million acquisition of the manufacturer and distributor of a high-end range of hemp-derived CBD products.
